- Section 3 is completed by the external auditor appointed by the Audit Commission.
- Section 4 is completed by the board's internal audit provider.

Each board must approve this annual return no later than 30 June 2015.

Your external auditor will identify and ask for any additional documents needed for their work. Therefore, unless requested, do not send any original financial records to the external auditor.

Once the auditor has completed their work, certified annual returns will be returned to the local council for publication or public display of sections 1, 2 and 3. You must publish or display the annual return, including the external auditor's report, by 30 September 2015.

It should not be necessary for you to contact the external auditor for guidance.

Except for the matters reported below, on the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

As in the prior year, the Board was unable to provide documentary evidence to demonstrate risk management has been reviewed by those charged with governance during the year. We note that the Board does not currently have a Risk Management Strategy and Policy but has discussed plans to create one. This should be done in a timely manner.

Other matters not affecting our opinion which we draw to the attention of the Board:

Revised guidance in respect of the treatment of fixed assets is expected to be communicated on behalf of the Association of Drainage Authorities to all Internal Drainage Boards for the 2015/16 and subsequent years. The Guidance is expected to indicate that assets should be recorded at their original cost (or a proxy such as insurance value where this is not known) and no adjustment is required until disposal. Please ensure the figures on the 2015/16 Annual Return in respect of 2015/16 and 2014/15 are amended accordingly.

The Annual Return was not accurately completed before submission for review. The Clerk has confirmed that, as in the prior year, a transcription error was made and Section 1, Box 9 should read £1,266,000 for both years.

The Board has not provided a copy of its Section 48 notice for the year 2014/15, as requested in our instruction letter.
