Meeting: 2017/03**

Minutes of the ADA Branch Meeting were presented and approved.

**ADA Technical Manager
Ian Moodie 2017/04**

Mr Moodie gave an update on what ADA were doing at present. He explained the different membership structure and rates.

How ADA were working with Defra on a methodology for the transfer of valuations to special levy. Mr Moodie also mentioned Defra's Water Transfer Licence and the potential that IDB's could be charged and that we need a good working relationship with the Environment Agency. He also mentioned the renewal of the licence for the use of Glyphosate, and that ADA are keen to keep using as it is ecologically a safer way than machine cleaning

Mr Moodie mention the new ADA website and was interested to find out what members thought about this new website.

Mr Moodie stated that the Floodex Trade Show will be held on 17 and 18 May 2017 at Peterborough.

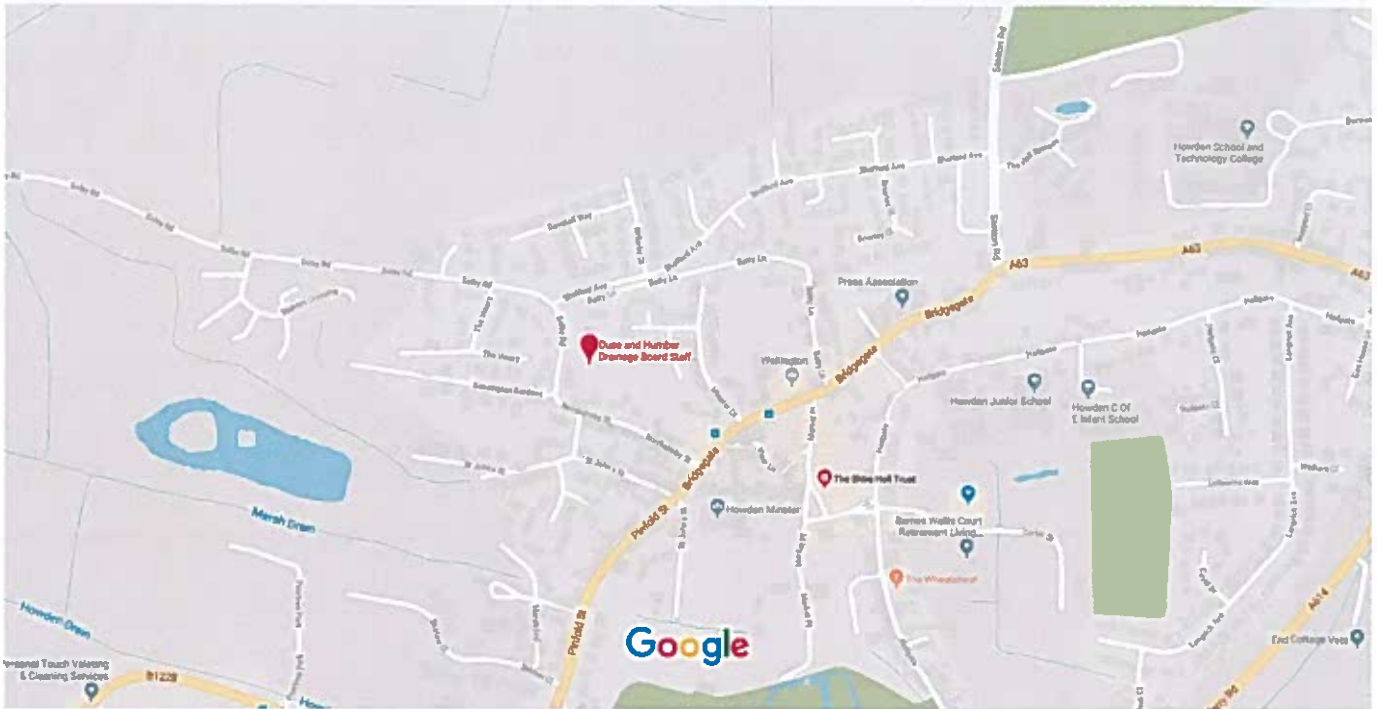
