



Privacy Notice for Members of the River Lugg Board

Information Held About you

In order to carry out the duties as a Board Member for the River Lugg Internal Drainage Board as specified in the Land Drainage Act the River Lugg IDB, The Board will collect personal data about you as appropriate.

This information will include:-

- *Details such as your name, address, telephone number, email address, date of birth and emergency contacts.*

Who is processing my data?

All personal data held, is processed in accordance with the data protection law. The Data Controller for the information outlined in this privacy notice is the River Lugg Internal Drainage Board.

Hoople Ltd is the Data Processor who will process your information on behalf of the River Lugg Internal Drainage Board.

How will we use the information we hold about you?

We will collect information about you (where applicable) to:-

- Enable the Board to comply with its duties in line with the Land Drainage Acts 1991 and 1994
- Health and Safety legislation

What is the legal basis for us to process your data?

The legal basis for processing the data is:

- Our legal obligation under the Land Drainage Act 199 and 1994
- The prevention/detection of crime, including false representation in accordance with the Fraud Act

Who we will share your information with

We may share your information with partner organisations, including:-

- Hoople Ltd for the purposes carrying out the duties of the role as management support to the Board.
- Names of current Board members are available on the River Lugg IDB website.
- Limited Board member details are shared amongst the Board to facilitate communication between board members on Board related activities.
- Minutes from meetings and annual reports are available on the River Lugg IDB website.
- To obtain appropriate insurance cover, limited details may be shared with insurance companies.
- Association of Drainage Authorities (ADA)
- On occasions, your information may be accessed by contracted IT support organisations in the delivery of IT support for both the IT infrastructure and associated systems, for the processes detailed in this privacy notice. Access by IT support will only be for such reasons as fixing any technical issues with software, and any viewing of data will be incidental to this.

We will not normally share your information with organisations other than our partner organisations without your consent, however, there may be certain circumstances where we would share without

consent such as where we are required to do so by law, to safeguard public safety, and in risk of harm or emergency situations. Any information which is shared will only be shared on a need to know basis, with appropriate individuals. Only the minimum information for the purpose will be shared.

How long do we keep your records

We will only keep your information for the minimum period necessary. The information outlined in this privacy notice will for Board members be kept indefinitely, with the exception of date of birth and emergency contact details which will be destroyed 6 months after ceasing to be a board member. All information will be held securely and destroyed under confidential conditions.

Your rights

You have a number of rights under data protection law, including the right to request your information and to request that the information be amended or erased if incorrect.
